



**EXECUTIVE ORDER NO. 11-A**

Series of 2013

**AN EXECUTIVE ORDER APPOINTING THE HEAD OF THE OFFICE OF THE BUILDING OFFICIAL (OBO) TO BE ONE OF THE REGULAR MEMBERS OF THE BIDS AND AWARDS COMMITTEE (BAC) AND NAMING AND APPOINTING THE RESPECTIVE HEADS AND MEMBERS OF THE COMMITTEE'S SECRETARIAT AND TECHNICAL WORKING GROUP (TWG).**

**WHEREAS**, pursuant to Section 11.2.6 of the Revised Implementing Rules and Regulations of Republic Act No. 9184 which provides among others the membership of the BAC fixing their term of office to one (1) year reckoned from the date of their appointments, and renewable at the discretion of the Head of the Procuring Entity, on 8 July 2013, the undersigned issued Executive Order No. 11, series of 2013 entitled: "An executive order re-organizing and expanding the composition of the Bids and Awards Committee" re-organizing the members of the said body;

**WHEREAS**, in the first meeting of the BAC on 16 July 2013 at 2:00 o'clock in the afternoon, after finding the need, it was unanimously agreed by the body to recommend to the undersigned the inclusion in the regular members of BAC the Head of the Office of the Building Official (OBO);

**WHEREAS**, among the items that were discussed on that said BAC reorganizational meeting was the identification of the members of the BAC Secretariat and the members of its Technical Working Group (TWG) with their respective heads.

**NOW, THEREFORE, I, RONNEL C. RIVERA, City Mayor of General Santos City**, by virtue of the powers vested in me by law and the sovereign will of the people, do hereby order:

**SECTION 1. AMENDMENT OF SECTION 1 OF E.O. NO. 11, SERIES OF 2013.** Section 1 of E.O. No. 11, Series of 2013 is hereby amended to read as follow:

**SECTION I. COMPOSITION.** — The Bids and Awards Committee (BAC) for the City of General Santos is hereby re-organized and shall be composed of the following:

1. City Administrator's Office
2. Office of the City Legal Officer
3. Office of the City Budget Officer
4. City Engineer's Office
5. **Office of the Building Official**
6. City General Services Office
7. COA Representative
8. Accredited NGO as observer
9. Representative from the private group in a sector or discipline relevant to procurement at hand.
10. The Head of the end user department

The members shall elect from among themselves the Chairman and Vice-Chairman of the BAC subject to the relevant provisions of RA 9184.

**SECTION 2. THE BAC SECRETARIAT AND TECHNICAL WORKING GROUP (TWG).** — Pursuant to existing laws, rules and regulations, the following shall be the members of the Secretariat and the members of the Technical Working Group (TWG) of the present BAC:

**SECTION 2. TERM OF OFFICE OF SECRETARIAT AND TWG MEMBERS.** — Unless sooner removed for cause, the members of the BAC Secretariat and Technical Working Group (TWG) shall have a fixed term of one (1) year reckoned from the date of their appointments renewable at the discretion of the City Mayor.

**SECTION 3. REPEALING CLAUSE.** — All orders, memoranda, rules and regulations, or any part (s) thereof, inconsistent with the provisions of this Order are hereby revoked or modified accordingly.

**SECTION 4. SEPARABILITY CLAUSE.** — If any provision or part hereof is held invalid or unconstitutional, the remainder of this Order not otherwise affected shall remain in full force and effect.

**SECTION 5. EFFECTIVITY.** — This order shall take effect immediately.
