AN EXECUTIVE ORDER REACTIVATING AND CONSTITUTING THE AD HOC COMMITTEE FOR THE INITIAL SCREENING OF GENERAL SANTOS CITY POLICE APPLICANTS FOR THE 1ST CALENDAR YEAR 2013 ATTRITION RECRUITMENT PROGRAM OF THE POLICE REGIONAL OFFICE 12 AND OTHER MATTERS.

WHEREAS, the 1st Semester Calendar Year (CY) 2013 Attrition Recruitment Program has commenced and Police Regional Office 12 was allotted two hundred forty-eight (248) slots for Attrition Quota;

WHEREAS, of the two hundred forty-eight (248) slots for Attrition Quota for Police Regional Office 12, General Santos City has been allotted forty (40) slots;

WHEREAS, with the aforementioned and with the advent of the new administration, there is a need to reactivate and reconstitute the City's Ad Hoc Committee to initially screen police applicants and their documents to fill-in the allotted forty (40) slots for the City;

NOW THEREFORE, I, RONNEL C. RIVERA, City Mayor of General Santos, by virtue of the powers vested in me by law and the sovereign will of the people, do hereby order:
